### OLD BUSINESS:

Chief Freddy Johnson advised that bids for the foam trailers have been sent out. He also stated that budget forms have been printed for expenditures from the Special Fire Taxes account.

### **NEW BUSINESS:**

The Fayetteville Observer will published a story on Cumberland County Fire Departments, date of publishing is unknown at this time.

### COMMITTEE REPORTS:

- Fire Marshal Mr. Strickland announced that his office is receiving incomplete fire reports and stressed the importance of this information. He advised that a computer program is available for incident reporting; that by using this program it would allow departments to forward a disc to the Fire Marshal's Office. Mr. Strickland reminded departments that Report of Fire Conditions are due in his office no later than September 30, 1994.
- Emergency Management Ms. Grabowski announced several upcoming classes that were available to the fire and rescue services personnel.
- F.T.C.C. Mr. Vile announced that effective immediately, the airport training facility is available to all county fire departments. Departments are welcome to send members to observe the operations for future use. He also announced upcoming classes that would be sponsored by the school.
- E.M.S. Mr. Rich announced that a meeting is scheduled for 19:00 hrs. Tuesday, September 27, 1994, for all interested departments to discuss EMS First Response.

President Hall stated that his station will host a meeting at 19:00 hrs. on Wednesday, October 3, 1994, for chiefs' and their Board members to discuss problems with rescue and ems.

Sheriff's Office - Chief Johnson, Arson Task Force Commander, announced several changes are being implemented, effective October 2, 1994, - Teams will respond when called, he and Merrill would respond to special request from the team leader, commercial structures, or fatalities. The task force will now except more than two members from a given station, applications may be obtained from himself or the Chiefs' Association Secretary. He also informed chiefs that a bill is needed for the case file of all arson related calls, which will enable departments to collect restitution.

An application was received from David Austin Pate for the arson task force.

There being no further business, the meeting was adjourned at 20:30 hrs.
