Next Chief's Meeting will be hosted September 27, 2010 by Fort Bragg Fire and Emergency Services. The meeting will begin at 7:00 pm. The meeting will be held at the Varsity Drive Community center. If you come in the Butner Rd. gate off of Bragg Blvd, go past the 2nd set of traffic lights. As you start down the hill, Varsity Drive is on your right. The community center is located on your right just down the street. Due to mission requirements the General will not be able to attend this event. We will continue to pursue this endeavor and I will provide further information at a later date. The dress for this event no longer requires your formal attire, please feel free to wear whatever you desire.

- President Johnson advised the members that all of the foam trailers are in service.
- President Johnson handed out packets which contained; budget information, highway management team report, Memorial Service flyer, several letters, educational announcements, grant information and a CC911 texting form.

- President Johnson thanked the Honor Guard for their service and issued each member a gift certificate to express our appreciation for their service.
- The public safety task force will meet August 31, 2010 to answer questions from the County Manager. If you have concerns or questions, please contact President Johnson.
- Battalion Commander Mims advised everyone of the "Guns and Hoses" softball game recently held at J.P. Riddle stadium. He advised that they would like to make this a tournament next year involving many of the local emergency services agencies.
- Deputy Chief Melvin advised the members of the upcoming First Responder Appreciation Day at the Airborne Museum on Bragg Blvd. It will be held September 10, 2010 at 4:30 pm.

OLD BUSINESS:

- Director Currie discussed the additional channel issue with the members. A purchase order
 has been given to Motorola for 7 additional channels. The communications center may be mov
 into the old health department building in the near future. CC communications center will begi
 dispatching HMPD units August 29, 2010. A new dispatcher training academy will begin in
 September with 8 new dispatchers.
- President Johnson stated that the Welcome Fire Department in Davidson County came by and picked up the old fire safety trailer.
- County Attorney Rick Moorefield addressed the membership and informed all members that he was planning on updating the county contract starting with the low wealth departments in order to meet the new funding disbursement timelines. He stated that the Board of Commissioners adopted the recommendation of the Public Safety Task Force to increase the supplemental fire tax for the purpose of increasing the number of paid personnel in each of the low-wealth departments. The costs of necessary insurance, retirement contribution, turn-out gear, uniforms, and protective equipment for new personnel may be included as part of the personnel cost. In order to make the first quarter's distribution for the months of July, August and September, it is necessary to get an updated contract in place for each of those departments. 

Lee Jernigan, NCDOT, welcomed everyone to the meeting and thanked them for their participation. Everyone introduced themselves to the group.

Matthew Harris, NCDOT Construction, provided the following status of construction projects in Cumberland County at the meeting:

- US 13 Widening from I-95 to the Sampson County Line. Expect lane closures and delays from 9:00 a.m. to 4:00 p.m. Monday through Friday. The project is in the final stages. The final lift of asphalt is underway. Expected completion is August 15.
- SR 2299 (Russell St.) Work description includes grading, drainage, milling, paving, and signals. Expect lane closures and detours. Project completion is scheduled for early December. The project is finishing phase 2 and will be closing the portion of roadway between Gillespie and Robeson Streets.

- SR 1131 (Cameron Rd.) at NC 59 Project is completed.
- Resurfacing 12 sections of secondary roads. Only punch list items remain.
- SR 1003 (Camden Rd.) Pavement widening from NC 59 to NC 162. Expect lane closures and delays from 8:30 a.m. to 4:00 p.m. Project completion is scheduled for June 15, 2012.
- SR 1363 (Elk Rd.) From SR 1132 (Legion Rd.) to US 301. Project completion is scheduled for September 2012. Expect lane closures and delays from 8:30 a.m. to 3:00 p.m. Monday through Friday. Clearing and grubbing operations are underway.
- Resurfacing- SR 1403 (Reilly Rd.), US 301, US 401 (Raeford Rd.), and NC 210 (Murchison Rd.).
 Description of work includes milling, resurfacing, and shoulder reconstruction. Concrete monolithic islands will be constructed on SR 1403 (Reilly Rd.). Completion is scheduled for September 2010.
- NC 24/87 (Bragg Blvd) from US 401 Byp. to north of SR 1437 (Santa Fe Dr./Shaw Rd.). Description of work includes grading, drainage, paving, widening, clearing and grubbing, signals, and overhead signing. The preconstruction meeting is scheduled for August 3, 2010.
- SR 1112 (Stoney Point Rd.) at SR 1108 (Lakewood Dr.) Intersection improvements: Widening for right turn lanes, curb & gutter and signal revisions. Project letting date is August 3rd and is scheduled for completion in December. Project will involve lane closures.

Randy Wise, NCDOT Construction, provided the status of the following of the following projects after the meeting:

- Future I-295 (Fayetteville Outer Loop) Structures are being constructed at Murchison Road. Project completion is scheduled for July 2012.
- NC 210 (Murchison Rd.) Widening of NC 210 north of the future Outer Loop and interchange at Honeycutt Rd. Expect lane closures intermittently. Traffic patterns will shift 4 to 5 times throughout the project. Project completion is scheduled for July 2012.

Bill Hammond, NCDOT Maintenance, provided the status of the following maintenance projects in Cumberland County:

- SR 1400 (Cliffdale Rd.) Removal of RRXing at the Budweiser Plant. Project is scheduled to start August 10th and be completed within 3 days, weather permitting. The entire road will be closed from Glensford Dr. to US 401 Byp. until completion.
- SR 2299 (Russell St.) Closing of the median break and island installation at Advance Auto starting August 2nd with lane closures until August 31st.
- SR 2299 (Russell St.) Will be installing liner in the storm drain line from SR 2311 (Gillespie St.) to bridge at Blount's Creek. Scheduled to start August 2nd and finish September 20th. Lane closures expected.

• SR 3704 (Palmerland Dr.) - Installation of liner in storm drain line from SR 1132 (Legion Rd.) to SR 1311 (Vardaman Ave.). Lane closures expected.

Nicky Garrell, NCDOT Bridge, provided the status of the following projects in the county before the meeting:

- SR 1229 Pipe replacement.
- NC 82 Pipe replacement near the Falcon area. Work should begin August 3rd, with the duration of work lasting 2 weeks.

David Willauer of IEM, Inc. gave a presentation on the North Carolina Regional Hazardous Materials Study Phase 1.

The team discussed the following general topics:

- A. Red Light Runner Crackdown Took place from June 7th to June 28th. Various members of Law Enforcement participated throughout the county. The crackdown was a success.
- B. Speed Crackdown/Fatalities An initiative was taken on by the City of Fayetteville to reduce speeding and fatal accidents.
- C. Overhead Sign Contract Ongoing project to replace the overhead signs with new, highly-reflective signs that do not require lighting.
- D. Raised Pavement Marker Contract Moving operations started in June and should be completed by September 30th. Work should start back in the next 2 weeks.
- E. Exit 58 Detour Map Will be discussed at the next meeting.

The team reviewed the following incidents:

- A. A fatal incident occurred Monday, May 31st on SR 1112 (Stoney Pt. Rd.). Vehicle ran off the left and struck a tree. Alcohol and non seatbelt were factors.
- B. An incident involving a gas line rupture occurred Monday, June 7th on SR 2299 (Russell St.). The incident resulted in a road closure for 5.5 hrs.
- C. A severe incident involving an overturned camper occurred Monday, June 14th on SB I-95 @ MM 47. Some injuries did occur with minor impact to traffic.
- D. A TIMS entry noted a high severity incident on I-95 NB Wednesday, June 16th between MM 68 & 69. Congestion was noted in the report. No further details at this time.

- E. A serious incident occurred on SR 2018 (Hillsborough St.) involving an overturned tractor trailer truck leaking diesel fuel. Minor injuries and traffic delays were experienced. Speed may have been a factor.
- F. A fatal incident occurred on US 401 (Ramsey St.), June 27th. A northbound vehicle ran off the road to the left and struck a tree. Fatigue may have been a factor.
- G. A high severity incident occurred Friday, July 2nd on SB I-95 at MM 50. Wreck in the median caused congestion.
- H. A TIMS entry reported a high severity incident on I-95, MM 65 on Saturday, July 3rd. Congestion was reported.
- I. A fatal incident occurred Monday, July 5th on SR 1451 (Manchester Rd.). The vehicle ran off the road to the right, struck ditch, rocks, and caught fire. Speed in excess of 100 mph was noted.
- J. A fatal incident occurred Wednesday, July 7th on SB I-95 at MM 51. The motorist was speeding, lost control, struck a bridge support and caught fire.
- K. A motorcycle accident occurred on US 401 Bus. (Ramsey St.) Thursday, July 15th. Traffic flow was back to normal within the hour.
- L. An incident occurred Thursday, July 15th on NB I-95 at MM 55 involving an overturned truck. No serious injuries occurred.


